- The preferred provider comes to know the treating practitioners that are more regularly involved in Workcover cases, facilitating stronger communication and understanding.
- A consistent overall approach to rehabilitation and Return-To-Work is more readily applied across multiple sites (if applicable for the employer) when dealing with one rehabilitation provider. Solutions developed at one site can be more readily transferred to other sites if applicable.
- Positive word-of-mouth about the provider passed among employees reduces the chances that newly injured workers enter into the rehabilitation phase with apprehension or uncertainty.
- It is easier to track and monitor Return-To-Work progress and results over time when dealing with a single provider.
- The preferred provider becomes familiar with the workplace and the possible alternate/suitable duties available. This can expedite early intervention and reduce the timeframes required to implement an effective Return-To-Work plan.
- A single point of contact for all matters related to rehabilitation is more convenient and can make it easier to resolve any issues should they arise.
